151. COUNTY & DISTRICT MEMBER REPORTS

Cllrs L Burr MBE and D Keal gave updates on the new North Yorkshire Council and the winding down of Ryedale District Council.

154. MAYORS REPORT

The Mayor updated members on the wall between the St Nicholas Street carpark and Stations Taxis, she checked on Ryedale District Council's (RDC) progress as we are approaching the end of the councils tenure. Quotes for repairs are taking longer than expected so work is likely to be carried out in April/May. The money to pay for this is agreed in RDC's budget so is ring-fenced for the work which is reassuring.

RDC is investigating putting a zebra crossing on Railway Street as part of the Malton & Norton Interconnectivity Study. The Mayor has asked them to look back at the Study as she believed there were also plans to put a crossing on Welham Road adjacent to Lidl, which is a black spot for pedestrians and cyclists. There have been a number of minor accidents and many near misses in the area so seems like an ideal position for a crossing especially with the arrival of a new garage and shop on Welham Road which is likely to make it an even more dangerous junction. The Mayor will update council when she hears back from NYCC/RDC.

158. 20's Plenty Campaign

Members received papers and considered a response to the '20's Plenty' campaign.

- (i) That the Council support all 30mph limit areas in Norton becoming 20mph limit areas, including Bazley's Lane, and also including the 40mph area west of Bazley's Lane in the 20mph limit area, and support Malton and neighbouring villages Broughton, Swinton and Amotherby in forming a common 20mph implementation area in their built-up areas, with Malton having their 40mph areas become 30mph limits, and with a 40mph buffer in the short distance between Broughton and Malton, and between Broughton and Swinton.
- (ii) That the Council authorise the clerk to put in a 20mph request using the procedure as laid out in the following County Policy, or any updated policy.
- (iii) That the Council ask the County to reduce costs and increase consistency by implementing the change across a large number of settlements at the same time in the area with one Traffic Regulation Order.

(iv) That the Council ask the County Council to put £1million a year into the County budget for implementation across the County until all 20mph requests are fulfilled, whilst removing the requirement for data collection.

RESOLVED – That members were in agreement of the motion for the 20's Plenty Campaign.
